Elements in the toolkit can also be utilized to help providers and Community-Based Organizations (CBOs) educate community members and engage care partners.



- Identify at least one clinical and one operational champion to initiate implementation in your facility or health system.
- Charter a team to establish a timeline for implementation. Establish realistic and stretch goals that align with your organization's priorities. Alliant Health Solutions Senior Quality Advisors are available to provide guidance and coaching throughout your planning, implementation, and evaluation processes and work with you to design any additional resources you identify as helpful to your delirium quality improvement project.
- Consider having your Patient and Family Advisors or Resident Council review the patient and family/carepartner brochures and flyers to ensure the message resonates with the populations and cultures in your service area.
- Adapt materials to address priorities or current gaps in your delirium processes.
- Add your logo to materials and consider positing on your facility website.
- Incorporate into all components of your staff education program including on-boarding, annual competency review and performance improvement plans.
- Develop a community education campaign to include articles, blog posts and social media posts.
