





SNF QRP Measure #11: COVID-19 Vaccination Coverage among Healthcare Personnel (HCP) (CBE #3636)

This measure was finalized in the <u>FY 2022 SNF PPS Final Rule</u>, which was published in the Federal Register on August 4, 2021 (86 FR 42480 through 42489). Data submission for this measure began October 1, 2021.

SNF QRP Measure #12: Influenza Vaccination Coverage among Healthcare Personnel (HCP) (CBE #0431)

This measure was finalized in the <u>FY 2023 SNF PPS Final Rule</u>, which was published in the Federal Register on August 3, 2022 (87 FR 47537 through 47544). Data submission for this measure began October 1, 2022.

This final rule finalizes requirements for the SNF QRP, including the adoption of one new measure beginning with the FY 2024 SNF QRP: the Influenza Vaccination Coverage among Healthcare Personnel (HCP) (NQF #0431) measure.



QRP Measure

- In the <u>FY 2023 SNF PPS final rule</u> (pages 47564–47580), CMS adopted two additional measures for use beginning in the FY 2026 SNF VBP Program year: 1) Skilled Nursing Facility Healthcare-Associated Infections (SNF HAI) Requiring Hospitalization measure.
- SNF QRP Measure #15: Potentially Preventable 30-Day Post-Discharge Readmission Measure – SNF QRP
- This measure was finalized in the <u>FY 2017 SNF PPS Final Rule</u> which was published in the Federal Register on August 5, 2016 (81 FR 52030 through 52034). Public reporting began 10/24/2019.
- SNF QRP Measure #16: SNF Healthcare-Associated Infections (HAI) Requiring Hospitalization
- This measure was finalized in the <u>FY2022 SNF PPS Final Rule</u>, which was published in the Federal Register on August 4, 2021 (86 FR.42473 through 42480). Public reporting began 4/29/2022.









Vaccine Recommendations for Fall

• Flu vaccine

-Protect against three flu viruses: an A(H1N1) virus, an A(H3N2) virus, and a B/Victoria virus

• COVID-19

-FDA (VRBPAC) meeting in early June for a decision on the formula







All three vaccines can be ordered through your medical supply company with an MDs order



Pfizer and Moderna have direct ordering



Pre-ordering for next year is available



COVID-19 Vaccine Ordering Options

Moderna

- mRNA vaccine: 60-day development
- Order directly at Modernadirect.com
- Freezer storage acceptable for up to nine months
- Minimum order requirement: one box (10 vaccines)
- Single dose, ready-to-use vials
- Reimbursement program available for unused vaccines

Pfizer

- mRNA vaccine: 60-day development
- Order directly at primevaccinespfizer.com
- Fridge safe
- Minimum order requirement: two boxes (20 vaccine requirement)
- Single Dose, ready-to-use vials
- Reimbursement program available for unused vaccines



COVID-19 Vaccine Ordering Options (cont.)

Novavax

- Non-mRNA protein-based vaccine, months to manufacture
- Technology resembles the Hep B vaccine
- Fridge Safe
- Minimum order requirement is two vials (10 doses)
- Only order through pharmacies or Medical Supply Company with MD orders
- Multi Dose vials, five per vial. (single dose next year)
- Reimbursement program for unused and opened vials



Pre-Order the COVID-19 Vaccine for Next Year

- Eliminate access issues by ordering your COVID-19 vaccines with your flu vaccines
- Direct ordering is now available
- Pharmacy pre-orders check with the pharmacy to see when available
- Medical supply company check to see when available





Billing

Part A Stay Resident

• The LTC pharmacy is not allowed to bill directly for Part B vaccines for residents in their Part A stay.

Therefore

• The vaccine product and administration fee must be billed by the facility using roster billing on a Part B claim.

Non-Part A/Long-Term Stay Resident

- The facility can use roster billing for both the vaccine cost and the administration fee on a Part B claim.
- The pharmacy can also bill for the vaccine administration and, depending on the contract, reimburse the building for the administration fee. If the pharmacy administers the vaccine, it will bill for the administration and keep the reimbursement.



Current COVID-19 Vaccine Availability For 23-24

PFIZER

Pfizer's anticipated stop shipping date means that Pfizer will stop shipping direct orders and wholesaler orders by the date noted ABOVE. Wholesalers will likely have 2023-2024 formula COVID-19 vaccines in stock beyond the 'Pfizer Stop Shipping Date' noted above. Still, please have your customers work with their respective wholesalers or distributors to place an order. Additionally, Pfizer has communicated to wholesalers when Pfizer will stop shipping 2023-2024 formula COVID-19 vaccines.

Moderna

Vaccines will remain available through Moderna Direct and continue to be shipped to the Wholesaler/Distributor channel until a new variant is available (anticipating August).

Most of the distributors have opened up prebooking the product for the Fall, so buildings can pre-book with their distributor now.
