

Arkansas had the 12th highest rate of gun homicides in the United States in 2022, with an average of 220 people dying by gun homicide and 291 people wounded by gun assaults each year. This is equivalent to 7.8 homicides and 9.6 assaults per 100,000 people.

CHI St. Vincent North Shooting, Chronology

Incident Date: September 28, 2022

Chronology of Events:

- Female patient on 4th Floor had male visitor in her room
- At approximately 9:54 a.m., a second male entered the room and shot the visitor of the patient
- 911 was called along with PBX emergency line
- Announcement made overhead of the active shooter event, and all occupants were advised the event was not a drill



CHI St. Vincent North Shooting, cont.

Chronology of Events:

- Xmatters (automated incident reporting system), crisis alert text dispatched to all North employees
- Local law enforcement arrived approximately five minutes after 911 call





CHI St. Vincent North Shooting, During Event

Incident Date: September 28, 2022

During the Event:

- Hospital was on lockdown
- Employees who could evacuate, evacuated
- A surgery was still taking place behind locked Operating Room doors
- Mobile Command center for Chief Information Officers (CIO) of CHI St. Vincent and local authorities was established



CHI St. Vincent North Shooting, cont.

During the Event:

- Media zone was established and managed by CIOs
- Suspect arrested just over an hour after the shooting, about 15 miles

from the hospital





CHI St. Vincent North Shooting, Lessons

Incident Date: September 28, 2022

Lessons Learned:

- Security needs more master keys, pass badges and maps placed for quick access by law enforcement
- Continue Run/Hide/Fight education
- Set up Command Post at alternative location and maintain it
- Off campus staff/leadership does not need to rush to the event



CHI St. Vincent North Shooting, cont.

Lessons Learned:

- Takes time for law enforcement to clear building, even after suspect is captured
- Pharmacy may not be able to deliver medications during event
- On-going surgeries
- Identify a location to place family of victim/victims
- Routine testing of Xmatters, crisis alert text system




- Process began in 2008

 - Changing demographic
 - Impact of opioid and behavioral crisis

WORKPLACE VIOLENCE

- Zero Tolerance Policy
 - De-escalate
 - Mitigate
 - Prevent
- Safety and wellbeing through vigilance and empathy



INCIDENCE OF VIOLENCE

In 2023

- 178 Workplace Violence Incidents
 - 5 resulted in injury to staff
 - 1 involved an armed external threat intercepted and taken into custody
 - 0 incidents of staff-on-staff violence
 - 0 injuries sustained by patients



SECURITY ASSESSMENT

2023 External Assessment of Security Practices and Preparedness

- Full review of policies and procedures
- Overwhelmingly positive feedback
- Areas of opportunity



SECURITY ASSESSMENT


IMROVEMENTS IMPLEMENTED:

- Lighting and external environmental observation improved
- Incoming behavioral patient weapon and contraband exclusion procedures
- Behavioral and Emergency Department infrastructure improvement
- Security communication system
- Formation of our Workplace Violence Committee
- Increased surveillance and access control capability
- Discreet flagging and notification system for patients and patient family members with previous instances of violent behavior
- Organization-wide education and practical evaluation in de-escalation and non-violent crisis intervention
- Main and off-site campus Run-Hide-Fight and active shooter protocol, site inspection, training and practical evaluation
- After-hours access control and monitoring


- First 10 minutes as a bedside caregiver

ALL ACTIVE SHOOTERS ARE INCIDENTS OF WORKPLACE VIOLENCE, BUT NOT ALL INCIDENTS OF WORKPLACE VIOLENCE ARE ACTIVE SHOOTERS.
