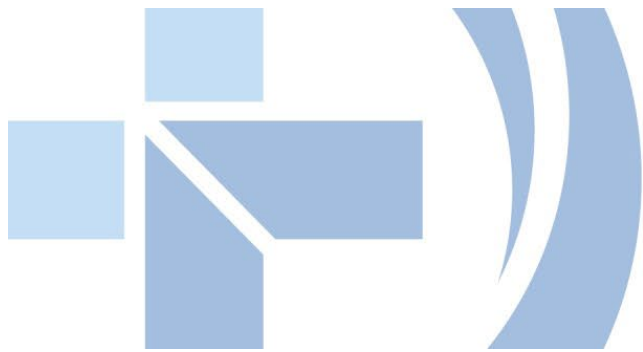

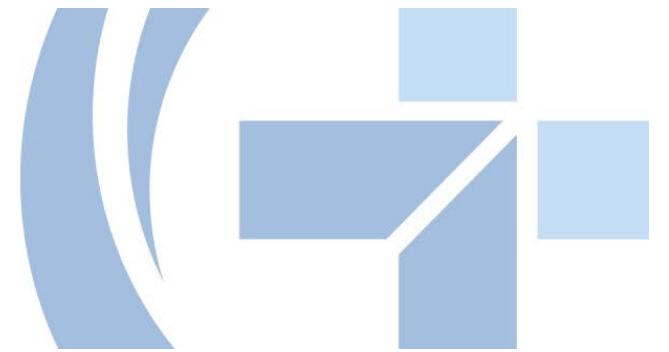

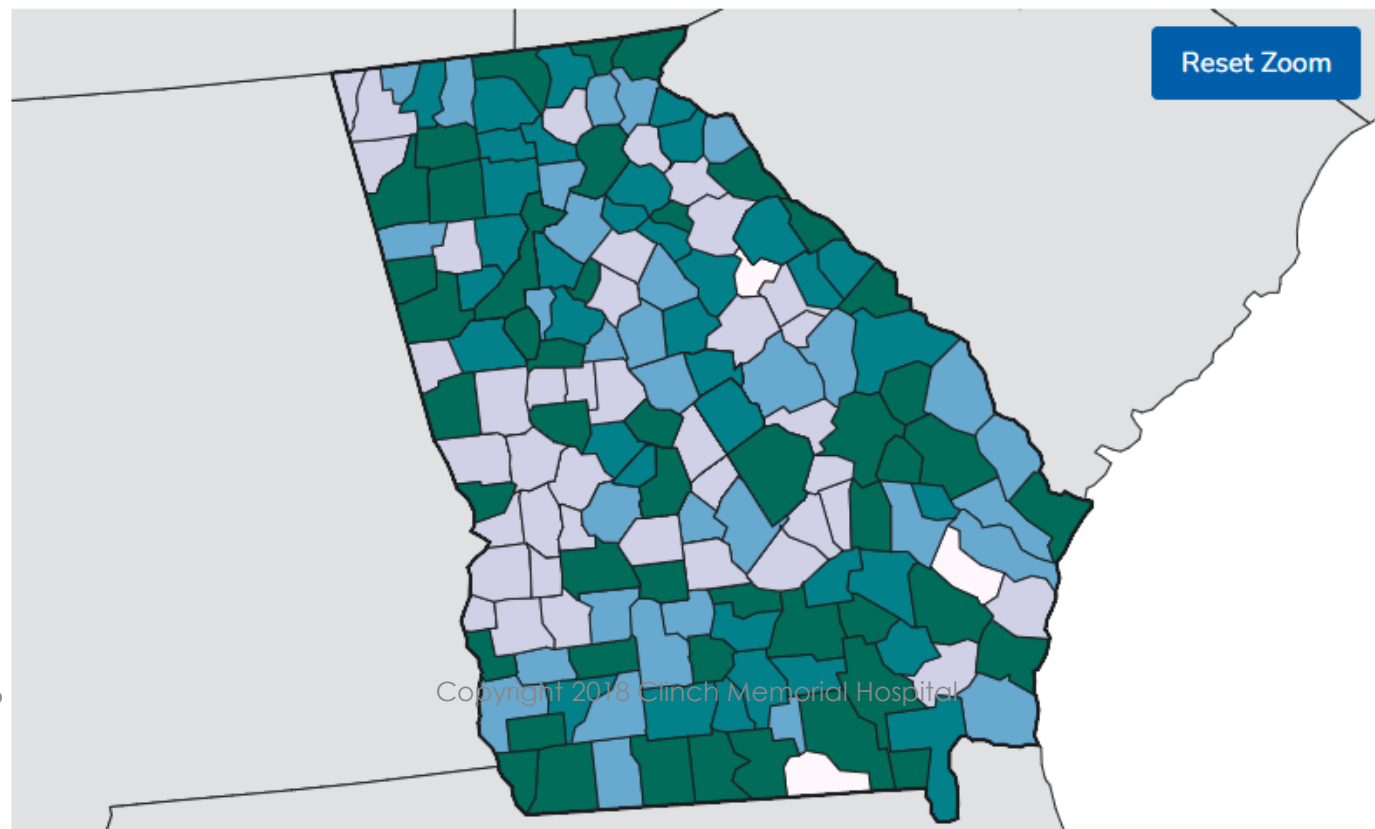
# Clinch County

Acute inpatient stay to address symptoms of withdrawal

# Our Response



## **Expanded clinical capacity**

Added providers to support MAT access and continuity of care



## **Integrated behavioral health**

Hired an LCSW to provide on-site counseling and care coordination



## **Removed transportation barriers**

Purchased a van to assist patients with access to treatment and services



## **Built recovery support on campus**

Initiated NA meetings at the hospital to support long-term recovery



## **Reduced financial barriers to treatment**

Grant funding covers office visits, counseling, and medication costs  
(including Suboxone and maintenance medications)

# What We Learned



Substance use disorder is **far more prevalent and complex** than initially understood

Many individuals developed dependence through **legitimate medical treatment**

**Stigma and long-held beliefs** create barriers to care and recovery

**One-size-fits-all treatment does not work**

# How We Evolved

Shifted from a single program to a **network of interventions**



Leveraged **community and regional resources** to expand care options



Recognized **multiple pathways to recovery** (MAT, counseling, support services)



Committed to **meeting people where they are**
